Event Guidelines, Information and Procedures

1. We reserve the right to cancel, terminate or relocate any space holder at any time.
2. Absolutely NO animals are permitted on the property or in any vehicles during the event. Sales of weapons, firearms, fireworks, knives, bows, arrows or anything similar to these items. Animals, pornographic material or any other illegal items are prohibited from being sold. Cedarburg Fireman's Park, Inc reserves the right to deem any item unsuitable to be sold at any of our events.
3. All vendors should conduct themselves in a professional and courteous manner or Cedarburg Firemen's Park, Inc reserves the right to ask you to leave.
4. **All food and beverage sales are reserved by Cedarburg Fireman's Park, Inc unless prior approval is obtained.** A current certificate of insurance listing Cedarburg Fireman's Park, Inc listed as an additional insured and any other necessary licenses are provided to the office.
5. No moving of vehicles on the grounds during the event of 6am to 2pm. Vehicles unloading inside the barn and grandstand may not be kept in the building overnight or for long periods of time with or without the engine running.
6. Everyone needs to drive slowly to and from your space. Vendors may park in their space as long as the vehicle fits in that space. **Only one pass is issued for each paid space.** You are limited to only your respective paid space(s). If your vehicle does not fit, you will need to park on the street or in the north parking lot.
7. If you would like to renew your space for the following year, you may do so at the October event. **Please do not assume that we know you are going to attend next years event.** Any returned checks will result in a \$50.00 fee.
8. Cedarburg Fireman's Park Inc is not responsible for any lost, damaged or stolen property. If you need to report theft of property, you will need to contact the Cedarburg Police Department by either coming to the office or calling them directly at 262-375-7620.
